NARD REPORT

Nelson reported the next board meeting will be held in Gothenburg on November 7, 2011. Thorburn reviewed NARD Resolutions.

COMMITTEE REPORTS

Planning Committee: Helms reviewed minutes of the meeting with Gosper County Commissioners and their concerns about acres being transferred out of the county. The planning committee explained the irrigated acre transfer process and that irrigated transfers aren't automatically approved. Thorburn mentioned a spreadsheet will be included in the packet every month to monitor movement of acres between basins and counties. Water levels in Union Township were discussed and that the current allocation needs to continue because water levels are still above 1981-1985 levels. Thorburn reported on REA measurements to be used in water pumping calculations and metering requirements in other NRDs. Thorburn suggested using ultrasonic flowmeter measurements could be used.

Moved by Helms, seconded by Johnson to accept the Planning Committee recommendation that Planning Committee review irrigated acre transfers in which 10 acres or 10% of parcel acres, whichever is less, on the destination field are HEL, provide HEL acre information to the board for the destination field with irrigated acre transfer requests and provide to the board a monthly tally of irrigated acres and transferred in or out of Gosper County and to maintain the current three-year allocation for Union Township pending review of fall groundwater levels. Motion carried. AYE: Harris, Helms, Johnson, Larson, Nelson, Raffety, Reynolds and Nickel NAY: Lundeen and Winz ABSTAIN: None

<u>ABSENT</u>: Bergstrom, Garrelts and Olsen

Nelson commented that every month there are requests for changes in certified acres and suggested that landowners be notified that as of March 2012, no more changes to certified irrigated acres will be made. Lundeen mentioned that MRNRD sent a letter to landowners to verify irrigated acres. Raffety commented that sometimes landowners don't inform producers or subsequent landowners about irrigated acre notices. Johnson commented that after this many years the landowner should know how many acres they have. Reynolds commented that there hasn't been opposition to approval of changes to irrigated acres. Thorburn commented that the Assessor sends acre changes every year and if the change is less than 4 acres, it's automatically revised by the NRD and if the change is greater than 4 acres, the landowner is notified. Nelson asked that Thorburn research how other districts handle corrections to certified irrigated acres send to the Planning Committee. <u>Moved by Nelson, seconded by Harris to notify landowners of current certified irrigated acres for verification so that no changes will be made to certified irrigated acres as of March 1, 2012. Motion withdrawn.</u>

Executive Committee: Thorburn reviewed Executive Committee recommendations. He explained sub-districts need to be revised because of new census population data and to stay in compliance with the one-man-one vote method of election adopted by TBNRD in 2001. Boundaries were changed in all sub-districts. Sub-District #1, as revised, includes three current Directors. Thorburn proposed that because Helms is building a new home outside the district and will need to resign when he moves, Johnson could be appointed to fill his seat and the remainder of his term. Subdistrict #4 would then need to have a new director appointed by the board. A Resolution to redistrict needs to be filed with Secretary of State by the November 8, 2011. Helms commented that

changing the map will make it harder for someone in the SW corner in Gosper county to get elected because of lack of

population. The area needs representation because the land is different and they have different concerns.

Thorburn explained that the Committee recommended approval of the Accountable Reimbursement Plan and purchase of office furniture from Eakes. Thorburn explained TBNRD's auditor recommended approval of the "Accountable Reimbursement Plan" and that it be included in the Personnel Policy to comply with IRS Regulations concerning taxation of meals and mileage expenses for staff and directors. Thorburn mentioned a motion was made to purchase a short-throw projector and smart board to replace the current power point projector. The motion was withdrawn to allow for more time to gather information and bids. The purchase of the projector and smart board will be presented at the November board meeting.

<u>Whereas</u> Nebraska State Statutes provide three methods for election of directors to serve on natural resources district boards, and

Whereas the Tri-Basin Natural Resources District Board of Directors unanimously passed a motion during the September 11, 2001 board meeting accepting a recommendation of the District Executive Committee that the NRD should adopt an electoral process by which "directors shall be elected only by the registered voters of the sub-district, except that an at-large director may be elected by registered voters of the entire district" as provided for in Nebraska state statutes Ch. 2, Sec. 3214 (2): Now therefore be it also resolved that the board of directors of Tri-Basin Natural Resources

District have divided the district into six sub-districts (one less than a majority of directors) of "substantially equal population' as provided for in Nebraska state statutes Ch. 2, Sec. 3214 (2), taking into consideration "... all factors including, but not limited to, the location of works of improvement and the distribution of population and taxable values within the district." A description of the boundaries of these sub-districts follows.

The First (1st) Sub-district shall consist of all of Gosper County and Garfield (7N-20W) and Union (6N-20W) Townships in Phelps County.

The Second (2nd) Sub-district shall consist of all of Center (7N-18W), Industry (5N-19W), Laird (6N-19W), Westmark (7N-19W), Williamsburg (8N-18W and 8N-19W), Rock Falls (5N-20W) and Westside (8N-20W) Townships in Phelps County, Sections 5 and 6 in Prairie (5N-18W) Township in Phelps County, and election ward #4 of the City of Holdrege in Phelps County, as it exists on the date of this resolution.

The Third (3rd) Sub-district shall consist of all of Lake (5N-17W), Divide (6N-17W) and Prairie (5N-18W) Townships in Phelps County, Mirage (6N-16W) Township in Kearney County and election ward #1 of the City of Holdrege in Phelps County, as it exists on the date of this resolution. The Fourth (4th) Sub-district shall consist of all of Sharidan (6N-18W) Township in Phelps County.

The Fourth (4th) Sub-district shall consist of all of Sheridan (6N-18W) Township in Phelps County and election wards #2 and #3 of the City of Holdrege as they exist on the date of this resolution, all in Phelps County.

The Fifth (5th) Sub-district shall consist of all of Grant (5N-13W), Cosmo (5N-14W), Sherman (5N-15W), Hayes (6N-15W) and Oneida (5N-16W) Townships in Kearney County and the South and Center election wards of the City of Minden in Kearney County, as they exist on the date of this resolution.

The Sixth (6th) Sub-district shall consist of all of May (6N-13W), Eaton (7N-13W), Lowell (8N-13W) and 8N-14W), Lincoln (6N-14W), Liberty (7N-14W), Newark (8N-14W and 8N-15W), Logan (7N-15W) and Blaine (7N-16W and 8N-16W) Townships in Kearney County and the North election ward of the City of Minden in Kearney County, as it exists on the date of this resolution, as well as all of Anderson (7N-17W) and Cottonwood (8N-17W and 8N-18W) Townships in Phelps County.

- 2. <u>The director or employee will account for each allowable expense in writing at least every 90</u> <u>days.</u> <u>Documentation will include the amount, date, place and business purpose for each</u> <u>expense.</u> <u>A receipt will accompany documentation.</u>
- 3. <u>Under this accountable arrangement the District will not report reimbursed amounts as</u> <u>taxable income on the director or employee's Form W-2. The director or employee should not</u> <u>report reimbursed amounts as income on Form 1040</u>

Platte Basin: PRRIP will need to replace LAC representative Scott Woodman. Thorburn will meet with COE and PRRIP on the 404 permit and hearing. Holloway mentioned the Wilke Pilot Project could provide offset and provide as a model for similar projects.

South Dry Creek: Nothing to report.

Sacramento Creek: Nothing to report.

Middle Lost Creek: Nothing to report.

Fort Kearny West: Nothing to report.

North Dry Creek: Phragmites will be sprayed and beaver trapping. Remote well startup was tested and corrected to work faster. Barbed wire fence will be installed on the north edge of property.

Whiskey Slough: Nothing to report.

Lake Seldom: Bullrush spraying was done.

CoHyst/PBHEP: CoHyst model will be calibrated late in November 2011 when Gosper County irrigated acres are added. Gosper County irrigated acres will not be as accurate because they were not mapped. Thorburn commented the calibrated model should be available in early 2012.

Weed Management Areas – Riparian Vegetation Task Force Platte: Weed Management Areas are working on Master Plan.

Sand Creek/Little Blue Basin: Thorburn will work on request for proposals on design work for Sand Creek Reservoir.

CNPPID: Ford reported irrigation season is winding down, Lake McConaughay is at elevation 3257.45 feet (two feet below FERC limit) and 5.9 inches per acre was delivered. The twenty year average is 9.4 inches/acre with rainfall two inches less than average. Ford attributed water savings to delivery timing and increased pivots. Reynolds suggested a joint letter be written to NDNR showing CNPPID water user savings and also publicized. Nelson commented that it would be valuable for the NRD and groundwater users if water usage savings could be shown using flowmeter data.

<u>Delineation of Electoral Sub-Districts</u>

<u>Whereas</u> Nebraska State Statutes provide three methods for election of directors to serve on natural resources district boards, and

Whereas the Tri-Basin Natural Resources District Board of Directors unanimously passed a motion during the September 11, 2001 board meeting accepting a recommendation of the District Executive Committee that the NRD should adopt an electoral process by which "directors shall be elected only by the registered voters of the sub-district, except that an at-large director may be elected by registered voters of the entire district" as provided for in Nebraska state statutes Ch. 2, Sec. 3214 (2); Now therefore be it also resolved that the board of directors of Tri-Basin Natural Resources District have divided the district into six sub-districts (one less than a majority of directors) of "substantially equal population' as provided for in Nebraska state statutes Ch. 2, Sec. 3214 (2), taking into consideration "... all factors including, but not limited to, the location of works of improvement and the distribution of population and taxable values within the district." A description of the boundaries of these sub-districts follows.

The First (1st) Sub-district shall consist of all of Gosper County and Garfield (7N-20W) and Union (6N-20W) Townships in Phelps County.

The Second (2nd) Sub-district shall consist of all of Center (7N-18W), Industry (5N-19W), Laird (6N-19W), Westmark (7N-19W), Williamsburg (8N-18W and 8N-19W), Rock Falls (5N-20W) and Westside (8N-20W) Townships in Phelps County, Sections 5 and 6 in Prairie (5N-18W) Township in Phelps County, and election ward #4 of the City of Holdrege in Phelps County, as it exists on the date of this resolution.

The Third (3rd) Sub-district shall consist of all of Lake (5N-17W), Divide (6N-17W) and Prairie (5N-18W) Townships in Phelps County, Mirage (6N-16W) Township in Kearney County and election ward #1 of the City of Holdrege in Phelps County, as it exists on the date of this resolution.

The Fourth (4th) Sub-district shall consist of all of Sheridan (6N-18W) Township in Phelps County and election wards #2 and #3 of the City of Holdrege as they exist on the date of this resolution, all in Phelps County.

The Fifth (5th) Sub-district shall consist of all of Grant (5N-13W), Cosmo (5N-14W), Sherman (5N-15W), Hayes (6N-15W) and Oneida (5N-16W) Townships in Kearney County and the South and Center election wards of the City of Minden in Kearney County, as they exist on the date of this resolution.

The Sixth (6th) Sub-district shall consist of all of May (6N-13W), Eaton (7N-13W), Lowell (8N-13W and 8N-14W), Lincoln (6N-14W), Liberty (7N-14W), Newark (8N-14W and 8N-15W), Logan (7N-15W) and Blaine (7N-16W and 8N-16W) Townships in Kearney County and the North election ward of the City of Minden in Kearney County, as it exists on the date of this resolution, as well as all of Anderson (7N-17W) and Cottonwood (8N-17W and 8N-18W) Townships in Phelps County. Motion carried.

ACCOUNTABLE REIMBURSEMENT PLAN

In accordance with IRS regulations 1.162-17 and 1.274-5T(f), Tri-Basin Natural Resources District, herein referred to as the "District" hereby establishes an accountable reimbursement plan for all directors and employees with the following terms and conditions:

- 1. <u>The District will reimburse only reasonable district related business expenses incurred by a</u> <u>director or staff member. Subject to budget limitations, such expenses will include:</u>
 - a) <u>Business use of automobile, up to the current IRS standard mileage rate currently being used by the District.</u>
 - b) <u>Business travel away from home: transportation, parking, lodging, meals/tips and</u> <u>any other expenses necessary to carry out the business of the District.</u>
 - c) <u>Convention, conference and workshop expenses</u>
 - d) <u>Continuing education expenses and books, as detailed in the Personnel Policy.</u>
- 2. <u>The director or employee will account for each allowable expense in writing at least every 90</u> days. Documentation will include the amount, date, place and business purpose for each expense. A receipt will accompany documentation.
