#### UNFINISHED BUSINESS

Review Contract with Olsson Associates for Platte-Republican Diversion: Travis Figard, Olsson and Associates was present to answer questions. Thorburn presented the revised Scope of Services, Contract and Letter of Agreement. When the Feasibility Study is completed then design work can begin. There was discussion about cost overages, landowner easements, water rights, CNPPID construction and additional funding from NDNR. Figard stated that costs exceeding those stated in the Scope of Operations would have to be pre-approved by TBNRD/LRNRD. Reynolds questioned the need for the full range of tasks outlined in the Scope of Services. Thorburn emphasized the importance of vetting the project thoroughly prior to construction because it's the first project of its kind in Nebraska and because the project affects many landowners. Winz and Johnson expressed that the Republican Basin IMP Stakeholders fully support proceeding with the project. Scott Dicke, LRNRD, stated that LRNRD approved the scope of work and is ready to start.

Moved by Garrelts to table the following motion until the July board meeting. Motion failed for lack of second.

#### NARD REPORT

NARD Blue Basin Tour, June 13-14: Reynolds commented on several issues: interference between domestic wells and ag wells is a concern. Landowners with CRP renewals are being advised by surface water projects to not to renew their contracts due to potential loss of water right (Reynolds asked that this be added to the Joint CNPPID agenda), potential NARD resolutions need to be submitted by August 19, 2016, NETV is producing a time lapse program targeted for education curriculum and will be asking each NRD to contribute \$2,000 in FY 2016-2017 and the Environthon will be held in Nebraska this year.

Brooks and Raffety reported on the Little Blue Basin Tour. There was discussion about connecting Sand Creek with the CNPPID Canal near Heartwell. Cavanaugh suggested investigating this option for the 2016-2017 Budget and also discuss at the Joint meeting with CNPPID.
