### CALL TO ORDER

**Presentation on Small Watershed Flood Control Fund (Kent Zimmerman, NDNR):** Kent Zimmerman, NDNR, gave a presentation on the Small Watersheds Flood Control Fund. The fund reimburses NRDs for land purchased in conjunction with flood control projects. Zimmerman explained that the land is purchased and a claim is submitted to the fund. When funds become available, the NRD is reimbursed for the purchase. Within ten years the NRD would obtain necessary easements and sell the land back to the public and reimburse the fund. Zimmerman commented that if land is leased or irrigation rights are sold, income is split between the NRD and the fund in the same proportion as the initial purchase.

**Consider Formation of Odessa IPA:** Thorburn reviewed landowner concerns: Wells is concerned about changing the drainage pattern and Erick Ray Erickson is concerned about assessing a portion of his property that he believes won't be affected by the IPA. Reynolds expressed concern about who will pay for the engineering evaluation.
