CALL TO ORDER

The regular monthly board meeting of the Tri-Basin Natural Resources District (NRD) was called to order by Chairman David Olsen, at 1:32 p.m. Olsen noted Public Meeting Law is posted in the boardroom. Schedule Public Hearing on Proposed Groundwater Quantity Phase 2 & Phase 3 **Designations:** Thorburn explained that May Township in Kearney County has passed the trigger level which qualifies the township for Phase II. The entire district is included in Phase I Groundwater Quantity Management. Phase II requires that flowmeters be installed, landowners report annual water use and additional limitations are required on irrigated acre transfers. Elk Creek Township in Gosper County has passed the trigger level and qualifies for Phase III, which implements allocations and additional limitations on well spacing. Thorburn would like to schedule landowner meetings in August and public hearings in September 2015. Moved by Winz, seconded by Harris to schedule landowner meetings on Groundwater Quantity Phase II for May Township in Kearney County and Phase III Groundwater Quantity for Elk Creek Township in Gosper County and schedule hearings at the September Board meeting.
